## Committee's activities:

- November 9, 2015: Committee convened and was charged by Assoc. Dean Kramer.
- Early-mid December, 2015: Committee members read, evaluated, and prepared summaries of tenure and promotion dossiers.
- December 10-17, 2015: Committee met four times during which 27 tenure (including 2
  "expedited tenure") and/or promotion dossiers were summarized, discussed and voted upon.
- January 11, 2016: Committee met to summarize, discuss and vote upon four tenure (including 1 "expedited tenure") and/or promotion dossiers.
- February 5, 2016: Committee met to summarize, discuss and vote upon final two tenure and/or promotion dossiers (during the regular cycle).
- March 9, 2016: Committee met with Dean Lee to discuss P&T process and recommendations for AY 2016.
- Spring-Summer 2016: Reviewed, met once, and voted upon final two expedited tenure cases.
